

# TERMS OF SERVICE

Please ensure you take the time to read these terms of service thoroughly, and fully understand them.

'I/the Artist' refers to Jodie Gallagher - Jodie Nail & Makeup Artist, 'You/the Client' refers to the booker of the service.

These terms are legally binding and are accepted as of the time and date the Client completes the form and returns to the Artist.



1. The Artist's obligation to provide services on the set date is subject to unavailability due to sickness, accident, adverse weather or any other reason outwith the Artist's control.
2. Bridal Makeup Trials aren't mandatory but are highly recommended to provide both the Client and the Artist the opportunity of introduction and familiarity before the Wedding Day. For Brides travelling from afar, Trials aren't always possible, so a video call can be organised to discuss your requirements.
3. The Booking Deposit of £100.00 is non refundable nor redeemable against any other services. This will be deducted from your final total balance. In the event the Client cancels the service before the remaining balance is paid, the Booking Deposit will be forfeited. In the unlikely event the Artist cancels the service, the Booking Deposit will be refunded.
4. If the Booking Party number is less than 5, the minimum charge of £420.00 will still apply. This is the starting day rate price and cannot be reduced.
5. The remaining total balance is to be paid 4 weeks before the set date. Once the balance has been paid, amendments cannot be made to the booking. If for unforeseen circumstances the Booking Party number decreases, no refund will be made. In the event the Booking Party number increases, additional costs will be incurred.
6. If services are cancelled by the Client within 3 months of the set date, the remaining balance will still be required to be paid in full. It's highly unlikely I will be able to secure another booking for the set date with such short notice.
7. In the unlikely event the Artist must cancel the services once the full balance has been paid, the full amount will be refunded and a replacement Artist will be sourced.
8. It is the responsibility of the Client to inform the Artist of any skin conditions, allergies or sensitivities. With all topical products, including skin care and makeup, there is a risk of irritation. The Artist accepts no responsibility or liability for any adverse affects or reactions from any products used.
9. The Client agrees to have photographs taken, by the Artist, of them and any one else included in the Booking Party that the Artist may work on. The Client agrees that the Artist may use these photographs for marketing/advertising purposes on the Artist's social media platforms and/or professional website. Children under the age of 16 cannot appear in Artist's photographs without parental consent.
